ORDER ON VEHICLE WEIGHTS**

ORDER NO. 17-07

By order of the Municipal Manager pursuant to Bylaw No. 354-99, being the General Traffic Bylaw of Brazeau County, it is hereby ordered that:

1. OIL BASED ROADS in the County will be:

1. Range Road 73 (Ring Road) from the entrance of Eastview Heights II south to Twp Rd 490, west to Helena Drive at 50%
2. Twp Rd 492 from Range Road 73 east to the Drayton Valley Cemetery at 75%
3. The internal roads of Parview Estates at 75%
4. The internal roads of Country Club Estates at 75%
5. The internal roads of Northside Acres and Fairway Meadows at 75%
6. The internal roads of Rex Block at 75%
7. Locality of Lindale at 75%

2. HAMLETS in the County will be:

1. Cynthia at 75%
2. Lodgepole at 75%
3. Buck Creek at 90%
4. Rocky Rapids at 90%
5. Violet Grove at 90%

3. GRAVEL ROADS in the County will be at 100% gross vehicle axle weights with the exception of:

1. Range Road 44A from Twp Rd 482 to Twp Rd 481 at 75%
2. Range Road 45 from Hwy 616 to Twp Rd 473 at 75%
3. Range Road 45 from Twp Rd 493 to Twp Rd 490 at 75%
4. Range Road 52 from Twp Rd 484 to Twp Rd 482 at 75%
5. Range Road 54 from Hwy 39 to Twp Rd 485A at 75%
6. Range Road 63 from Hwy 39 to Twp Rd 484 at 90%
7. Range Road 81 from Twp Rd 480 to Twp Rd 474 at 75%
8. Range Road 82 from Hwy 620 to Twp Rd 482 at 50%
9. Range Road 83 from Twp Rd 492 to Twp Rd 491 at 50%
- A. Twp Rd 473 from Range Road 34 to Range Road 33 at 75%
- B. Twp Rd 474 from Range Road 40 to Range Road 33 at 75%
- C. **Twp Rd 475A from 51 Street west in Lodgepole to Range Road 101A at 75%**
- D. Twp Rd 481 from Range Road 44A to Range Road 42 at 75%
- E. Twp Rd 482 from Range Road 42 to Hwy 20 at 50%
- F. Twp Rd 482 from Range Road 52 to Range Road 44A at 75%
- G. Twp Rd 482 from Range Road 63 to Range Road 60 at 75%
- H. Twp Rd 484 from Range Road 45 to Range Road 43 at 75%

- I. Twp Rd 484 from Range Road 53 to Range Road 52 at 75%
- J. Twp Rd 484 from Range Road 70 to Hwy 22 at 75%
- K. Twp Rd 484 from Range Road 71 to Range Road 70 at 50%
- L. Twp Rd 484 from Range Road 85 to Range Road 83 at 75%
- M. **Twp Rd 490A from Range Road 53 to Range 52 at 75%**
- N. Twp Rd 500 from Range Road 72 to Range Road 70 at 75%
- O. Twp Rd 504 from Range Road 82 to Hwy 22 at 50%
- P. Twp Rd 505 from Range Road 81 to Hwy 22 at 50%

4. **PAVED ROADS** in the County will be at 100% gross vehicle axle weights.

Exemptions shall be in accordance with the *Traffic Safety Act Commercial Vehicle Dimension and Weight Regulations (AR 315/2002)*, and; Special Circumstances:

The Director of Public Works or his designee is authorized in accordance with the Brazeau County's Motor Transport Policy to provide permits in special circumstances.

This Order comes into effect 8:00 a.m. Friday, May 5, 2017.

Order No. 17-06 is hereby rescinded.
