**ORDER ON VEHICLE WEIGHTS**

**ORDER NO. 18-06**

By order of the Municipal Manager pursuant to Bylaw No. 354-99, being the General Traffic Bylaw of Brazeau County, it is hereby ordered that:

1. **OIL BASED ROADS** in the County will be at 100% gross vehicle axle weights with the exception of:

1. Range Road 73 (Ring Road) from the entrance of Eastview Heights II south to Twp Rd 490, west to Helena Drive at 75%
2. Twp Rd 492 from Range Road 73 east to the Drayton Valley Cemetery at 75%
3. The internal roads of Parview Estates at 75%
4. The internal roads of Country Club Estates at 75%
5. The internal roads of Northside Acres and Fairway Meadows at 75%
6. The internal roads of Rex Block at 75%
7. Lindale hamlet Range Road 53 at 75%

2. **HAMLETS** in the County will be:

1. Cynthia at 75%
2. Lodgepole at 75%
3. Buck Creek at 75%
4. Rocky Rapids at 75%
5. Violet Grove at 75%

3. **GRAVEL ROADS** in the County will be at 100% gross vehicle axle weights with the exception of:

1. Range Road 45 from Hwy 616 to Twp Rd 473 at 75%
2. Range Road 61 from Hwy 39 south to the dead-end at 75%
3. Range Road 62 from Hwy 39 to Twp Rd 490 at 75%
4. Range Road 64 from Hwy 39 to Hwy 616 at 75%
5. Range Road 70 from Twp Rd 505 to Twp Rd 502 at 75%
6. **Range Road 72 from Twp Rd 482 to Twp Rd 474 at 75%**
7. Range Road 82 from Hwy 620 to Twp Rd 482 at 90%
8. Range Road 84 from Twp Rd 484 to Hwy 620 at 75%
9. **Range Road 90 from Hwy 620 to Twp Rd 480 at 75%**
10. Range Road 90 from Twp Rd 510 to Twp Rd 502 at 75%
11. Range Road 91 from Twp Rd 502 to Hwy 621 at 75%
  - A. Twp Rd 473 from Range Road 34 to Range Road 33 at 75%
  - B. Twp Rd 474 from Range Road 34 to Range Road 33 at 75%
  - C. **Twp Rd 474 from Range Road 71 to Hwy 22 at 75%**
  - D. Twp Rd 475A from 51 Street west in Lodgepole to Range Road 101A at 75%
  - E. **Twp Rd 480 from Range Road 72 to Range Road 71 at 75%**

- F. Twp Rd 482 from Range Road 50A to Range Road 44A at 75%
- G. Twp Rd 482 from Hwy 22 to Range Road 64 at 75%
- H. **Twp Rd 482 from Range Road 72 to Range Road 71 at 75%**
- I. Twp Rd 482A from Range Road 44 to Range Road 42 at 75%
- J. Twp Rd 484 from Range Road 45 to Hwy 20 at 75%
- K. **Twp Rd 484 from Range Road 71 to Range Road 64 at 75%**
- L. Twp Rd 484 from Range Road 85 to Range Road 83 at 75%
- M. **Twp Rd 485 from Range Road 91 to Range Road 85 at 75%**
- N. Twp Rd 490A from Range Road 52 to Range Road 45 at 75%
- O. Twp Rd 492 from Range Road 52 to Range Road 50 at 75%
- P. **Twp Rd 493 from Range Road 63 to Range Road 62 at 75%**
- Q. Twp Rd 495 from Range Road 73 to Range Road 71 at 75%
- R. Twp Rd 500 from Range Road 71 to Range Road 70 at 75%
- S. Twp Rd 502 from Range Road 91 to Range Road 90 at 75%

4. **PAVED ROADS** in the County will be at 100% gross vehicle axle weights.

Exemptions shall be in accordance with the *Traffic Safety Act Commercial Vehicle Dimension and Weight Regulations* (AR 315/2002), and; Special Circumstances:

The Director of Public Works or his designee is authorized in accordance with the Brazeau County's Motor Transport Policy to provide permits in special circumstances.

**Order No. 18-05 is hereby rescinded.**
