Public Input Session

Reeve B. Guyon opened the Public Input Session at 11:08 a.m.

Dixie Taylor indicated that the public have a right to address Council, and she sees the problem is that their questions are not being answered, like where is the money going? She brought up annual public meetings and that there needs to be a way to talk to public officials. She commented that both Council and public need to be respectful.

Susan Kelly spoke to public input session options, and commented that this session has been in place for a very long time and provides a valuable opportunity for public to make their views known. She would like to see in left in place, and supported option 1 from the report. She suggested Council ignore the municipal inspection report as it is six years old and was directed at a different council at the time.

Sara Wheale has received a number of calls regarding public input and feels that Council doesn't like the pressures they are receiving from the public. She encouraged Council to pay attention to this pressure. She commented that Council doesn't follow its own procedural bylaw and often suspends its own bylaws and policies by way of motion or not following them at all; this is waste of staff time and County money to create a policy that will be ignored or tossed out the window when it doesn't suit the whim of Council. She emphasized that there are better things that can be done with county resources. She stated this was not an accusation but a fact and she could bring in her notes and the motions of all the times council suspended their own policies.

Alan Taylor commented on the council workshop on fencing road allowances and asked when would it be completed? He spoke is regards to campgrounds and understands having a few campers in the yard and agrees with not regulating it. He mentioned it has been a long time since Council has had a general meeting, and Council should let the people know what is happening, where they are building roads and spending money. People get frustrated when they don't know. He asked for follow up on his letter sent to all of Council regarding Bylaw 1010-18 and how long will it take to get a response?
