at the Drayton Valley Landfill for household waste. County residents are encouraged to take their acceptable household garbage to their local Brazeau County transfer stations where there are no disposal fees.

Scrap Metal Recycling

Brazeau County residents can recycle SCRAP METAL to the Violet Grove, Rocky Rapids, Buck Creek and Lindale transfer stations (year round).

Please use the Transfer Stations during the regular hours of operation.

Acceptable Items:

Pressurized containers ONLY IF

PUNCTURED or WITH VALVES REMOVED

- Steel—Cast Iron
- Stainless Steel
- Aluminum—Brass
- Copper—Lead
- Metal Alloys—Electrical Wire

ALL SCRAP METAL MUST BE UNLOADED BY HAND

Unacceptable Items:

- Sealed or pressurized containers
- Radioactive material
- Asbestos or products containing such biohazard material
- Chemicals or product containers containing flammable liquids, oily material, chlorine, caustic soda, or other controlled substances
- Ammunition or ordinance
- PCB containing material
- Batteries
- Scrap containing excess amounts of debris (dirt, concrete, tar, etc.)

Other items deemed unacceptable that are not on this list are at the discretions of the Transfer Station Attendant



Please be advised that all County landowners have been issued a Transfer Station Identification Card. Anyone living in the household of the card holders can present the card at the Transfer Station to deposit acceptable waste.

If renters or additional, separate residents need an Identification Card, the registered landowner must apply for an addition card and is ultimately responsible for that card under the terms and conditions outlined by Brazeau County.

Brazeau County Goes GREEN!

The "Blue Bag" program as it is commonly referred to is now set up at all eight transfer sites throughout the County.

The Blue Bag program allows residents to recycle their household recyclables without the bother of sorting it. Clean recyclable products can all be put into the bags and taken to the nearest transfer station.

CleanFARMS

Brazeau County works in conjunction with CleanFARMS to provide a recycling program for pesticide and herbicide containers. Through stewardshipfirst[™] and CleanFARMS program, more than 70 millions empty plastic pesticide containers have been collected across Canada since the program's inception making Canada a world leader in container management.

CleanFARMS highlights the industry and farmers' commitment to container recycling. Farmers across the county are participating in this voluntary-led program, resulting in the return of over 73% of all empty pesticide containers annually. CropLife Canada, its members, farmers and various industry stakeholders work together to ensure that empty containers are appropriately rinsed and disposed of safely. CropLife Canada pucks up containers at the return sites, shreds them and transports the material to various recyclers, where it manufactured into drainage tile for use back on the farm.

It is so easy, and there is no cost the farmer/resident. Containers should be pressure-rinsed or triple-rinsed and the paper booklet removed, then returned to their local dealer. Just rinse, remove and return.

With a 73% participation rate, more than 70 million containers recycled and the best results in the world, we can safely call this a great success, pat ourselves on the back and leave it at that, right? Wrong. As with any initiative, when you achieve success, the smartest next step is to build on that success to achieve even better results. So we're setting the bar a little higher. With Canadian farmers clearly on board, a recycling rate of 80% of pesticide containers that go into the marketplace by the end of this year.

The success of CleanFARMS is thanks to the commitments of farmers, manufactures, dealers and distributers. Stakeholders will be working hard this growing season, staging collection centers and transporting rinsed and returned containers to recycling facilities. Thanks to your commitment, we are all doing out part to continue to protect out farms, our families, our health, and the environment.

GARBAGE

Acceptable Garbage Bag Content:

(This list does not include all possible garbage material).



- Disposable diapers
- Dirty or greasy paper or cardboard
- Tissue paper, paper towels
- Frozen juice cans, powdered drink containers
- Pet food bags, shredded paper

METAL

Foil wrap, clothes hangers, loose can lids



- Styrofoam (egg cartons, packaging, etc.)
- Chip bags, cellophane, food wrap
- Soiled plastics
- Clear bakery containers, string, strapping
- Bubble wrap
- Dishes, cutlery
- Toys
- Toothpaste tubes, garden hoses

FOOD WASTE

All food waste (table scraps, spoiled food, peelings etc.)

RECYCLING



Blue Bag Collection and Recycling Information

It's as Easy as 1, 2, 3.

Put your clean bottles, cans, plastics and papers into the blue bag (bag optional).

Take your blue bag to the Drayton Valley Landfill or any of our Transfer Stations. (Items do not have to be in a blue bag).

Feel good that you are helping to reduce the amount of waste that goes into our landfills.

PAPER

- Newsprint, insert, flyers
- Writing & computer paper
- Envelopes, paper egg cartons
- Paper bags, magazines
- Greeting cards, gift wrap
- Cardboard boxes (flattened)
- Cereal, shoes, tissue, cracker cookie boxes (remove liners)
- Milk cartons, juice boxes
- Paperbacks

METAL

- (Empty & clean, discard lids or trap inside can, labels okay)
- Cans, (food, beverage, soup)
- Aluminum cans & empty nonhazardous aerosol cans.

Household bottles and containers (vinegar, shampoo, fabric softener, dish/clothing detergent, pop, water, milk jugs, yogurt or butter, washer fluid, ice cream)

PLASTIC



(Grocery, retail, bread, dry cleaning). Please place into one plastic blue bag.

GLASS

- (Empty & clean, labels okay)
- Jars, (pickle, jam, mayonnaise)
- Bottles (beverage, ketchup, salad dressing, baby food, etc.)

NOT PERMITTED:

Any soiled or contaminated materials should be kept out of the Blue Bags and put into regular garbage bags. Consider the workers that have to sort through the recycling bags; make sure you do not have exposed sharp objects in the Blue Bags.

Brazeau County Pesitcide/Herbicide Container Recycling Program

Triple rinse your herbicide and pesticide containers. Remove any labeling and the cap. Return to one of Brazeau County's 5 sites that have a yellow container recycling bin.

Bins are located at the following Transfer Stations:

- Breton
- Violet Grove
- Buck Creek
- Lindale
- Rocky Rapids



STATION LOCATIONS



Please utilize one of Brazeau County's transfer stations to dispose of your household waste within the posted hours of operation. Leaving waste outside the locked gates of a transfer station is illegal and violators will be prosecuted. Unless otherwise stated the following wastes are not accepted at the waste transfer stations: tires, concrete, demolition, scrap metal, appliances, animal carcasses or hazardous waste.

North side of the Hwy. Located on Secondary Hwy 620, 600m past the intersection of Secondary Hwy 753 on the South side of Secondary Hwy 620.

*Drayton Valley...Hwy 22 and Rge Rd 74A directly West of Boston Pizza, follow Rge Rd 74A for 800m

*Please Note that the Drayton Valley Aspen Waste Facility is not a County run transfer station and fees will apply
