WHEREAS, the Owner or Lessee has requested the County to maintain the private driveway when such driveway becomes impassable or hazardous due to weather conditions; and

WHEREAS, Council for the County had authorized the maintenance of private driveways when such driveways become impassable or hazardous due to weather conditions.

- Place the flag at the end of your driveway <u>immediately</u> after a snowfall has ended (visible from the public road), <u>ONLY</u> when you wish to have your driveway plowed. Placing the flag out after the grader has gone by is too late.
- If your driveway is accessed by a paved road, please call 780-542-7777 and let the County know when you've placed your flag out.
- The plowing season is from October 1<sup>st</sup> to September 30<sup>th</sup> of any given year.
- The first plowing of the season is free, each plowing after is a minimum charge of \$20.00 plus GST.
- Seniors are free if the "EXEMPTION DECLARATION" section of this agreement has been executed.
- 2. The grader will make one pass into the residence and one pass out, <u>only</u>. The County will not plow out fuel tanks, corrals, parking areas, etc.
- 3. The plowing will happen only when it is convenient for the County to do so. After the most recent snowfall event has ended, expect a wait of up to 7 days before driveways are plowed. If immediate plowing is required, the landowner/resident will have to seek other options to have the snow removed. The County's first priority is public roads.
- 4. It is the landowner's responsibility to ensure there is enough room to accommodate the grader.
- 5. The County has the right to refuse service. If the driveway is "treed" in, meaning if a grader cannot make it in and out without damaging the grader with limbs breaking antennas off etc., then the County will not plow the driveway.
- 6. The County is not responsible for any damage to the private property.

NOW THEREFORE, the County and the Owner or Lessee for the consideration hereinafter named, agree as follows:

- 1. The County agrees to snowplow the private driveway when so requested by the Owner or Lessee, however the County shall not be under any obligation to do so and the maintenance shall be carried out at the sole discretion of the County. Maintenance will be affected by the COUNTY road priorities, work schedules, weather or other conditions. The County will attempt to carry out the work within seven (7) working days.
- 2. The County shall have the right to refuse to snowplow any private driveway that is, in the County's sole opinion, hazardous or impractical to do so, in any way whatsoever.
- 3. The charge(s) to carry out the snowplowing of private driveways will be as follows:
  - a) The first snowplowing per season (fall to spring) will be at no charge.
  - b) Additional snowplowing will be charged at the current Alberta Road Builders & Heavy Construction Association (ARHCA) rates with a minimum charge of \$20.00.
- 4. Exemptions of clause 3 shall be as follows:
  - a) No charge for snowplowing to community centers (halls), and cemeteries.
  - b) No charge for snowplowing in situations requiring immediate medical attention or funerals.
  - c) Snowplowing of private driveways and/or roads that become impassable or hazardous due to snow conditions will be charged according to the current Alberta Road Builders & Heavy Construction Association rates with a minimum charge of \$20.00.
  - d) Snowplowing of private driveways for commercial property, industrial property and trailer courts may be carried out at the discretion of the County when private equipment is not available and at the current Alberta Road Builders & Heavy Construction Association rates.
  - e) Exemptions over and above the standard one plowing at no cost is being offered to households where an able bodied individual (usually male) does not reside on the premises. More specifically, this could apply to seniors (that live alone on the property), disabled or handicapped (when no other able bodied individual resides on the property), and widows who cannot carry out the work themselves (or have no other able bodied individual on the property). Individuals must sign the declaration stating their eligibility.
- 5. The County shall forward to the Owner or Lessee statements showing all charges incurred by the Owner or Lessee for snowplow maintenance jobs done by the County and the Owner or Lessee covenant and agree to pay for all charges not later than thirty days immediately following the invoice date of the account by the Owner or Lessee. In the event that the Owner or Lessee does not pay his account, the County will refuse to do further snowplowing until the account is paid and any account remaining outstanding shall be a debt to the County.
- 6. The Owner or Lessee hereby covenant and agree that he will at all times indemnify and save harmless the County, its servants and employees from and against all loss, damage, injury or liability sustained, however caused, which may at any time arise while the County is maintaining the private driveway of the Owner or Lessee.
- 7. The Owner or Lessee hereby covenant and agree that any damage to the Owner or Lessee property resulting from the maintenance operations carried out by the County shall be at the Owner or Lessee risk and the County shall not be responsible for any loss, damage, or injuries sustained by the Owner or Lessee as result of the maintenance by the County on the Owner or Lessee driveway.
- 8. This agreement may be cancelled by either party give a (7) seven day written notice to the address appearing above.
- 9. This agreement cannot be assigned or transferred.
