TERMS OF SERVICES

RIGHT TO CANCEL PRE-NEED PLOT BY PURCHASER:

You may cancel this contract at any time for any reason. You may cancel without charge or penalty at any time during the period from the day you enter into the contract until 30 days after you receive a copy of the contract. If you cancel after 30 days, you may still have to pay for interment space and for any cemetery supplies and cemetery services that have already been supplied, performed or delivered, as the case may be.

If you cancel this contract, the seller has 15 days to refund any money you are owed. To cancel, you must give a notice of cancellation to Brazeau County, the owner of the cemetery, columbarium or scatter garden monument at the address shown in the contract. You should give notice of cancellation by a method that will allow you to prove that you gave notice, such as registered mail, fax, courier or by personal delivery

RESALE OF INTERMENT SPACE:

After the penalty-free 30-day cancellation period is over, Brazeau County will not allow you to resell your interment space on the open market. Brazeau County will buy back the unused interment space from you, if you wish, and will pay you 85% of its current market value of the interment space.

GREEN BURIAL PLOTS:

The Lodgepole Cemetery Green Burial Area is a certified green burial area by the Green Burial Society of Canada. Green burials are required to adhere to the following 5 guiding principles as outlined by the Cemetery:

1. No embalming
2. Direct Earth Burial
3. Ecological Restoration & Conservation
4. Simple Memorialization
5. Optimized Land Use

Pre-purchasers of green burial plots acknowledge that the plot for interment will be assigned at time of need only.

Brazeau County is not responsible for the care of monuments, markers or gravestones. Brazeau County is not responsible for any loss or damage to monuments, markers or gravestones for any reason whatsoever. The owner is responsible for the installation and ongoing care of all monuments, markers or gravestones. Brazeau County shall not be held liable for any harm, loss or damage.

The personal information contained on this form is collected under the authority of the Alberta Cemeteries Act and the Brazeau County Cemetery Bylaw, and will be used for the purpose of maintaining records for Brazeau County cemeteries, and may be disclosed in accordance with the Freedom of Information and Protection of Privacy Act.
