# **Council Highlights**

#### May 9 Appointment to Recreation Board

Council appointed Rina Saar to serve a two-year term as a member at large on the joint Town of Drayton Valley - Brazeau County Recreation Board.

The Board will initiate and provide direction for sport, culture, and recreation programs as designated by the councils of the Town and the County, and is directly accountable to the councils. It will be made up of two County councillors, two Town councillors, and two members-atlarge, one a Town resident and one a County resident.

The joint Recreation Board will make recommendations to the councils on the management and operation of the recreation and cultural facilities as agreed to by both the Town and County and as identified in the Recreation and Culture Cost-Sharing Agreement.

The Board is advisory and all recommendations must be approved by both councils in order to take effect.

#### Canadian Fire Rescue College

Director Erik Ives gave a presentation regarding the Canadian Fire Rescue College, which is exploring Lodgepole as a campus location to train firefighters. Council will provide the college with a letter of support for the project.

# County of Wetaskiwin No. 10 ICF and IDP

Council gave first reading to Bylaws 1178-24 and 1183-24 to repeal the Intermunicipal Development Plan and Intermunicipal Collaboration Framework with the County of Wetaskiwin No. 10.

This will reduce the levels of regulation on boundary lands between Brazeau County and the County of Wetaskiwin No. 10, while still being able to review statutory plans, land use changes, subdivision applications, and discretionary development along the intermunicipal boundary.

A public hearing on Bylaw 1178-24 will be held at the June 4th Council meeting.

# Appointment of Weed and Pest Inspectors

Council appointed Noahlea Townsend, Jenna Smith, Hannah Mahan, Lexis Elliot, Shaye Sommerfeld, Riley Rogers, Molly Goerzen, and Brent Erickson as weed and pest inspectors.

#### Council Meeting Livestreaming

Beginning with the May 21 meeting, Council meetings will be livestreamed on the Brazeau County YouTube channel.

The link to watch the livestream will be posted on the County Facebook page and website prior to the meeting. Concluded meetings will be saved to a playlist on the Youtube channel as well.

#### May 21 AG-19 Shelterbelt Policy

Council approved changes to the AG-19 Shelterbelt Policy as recommend by the Agricultural Service Board.

The changes remove reference to the defunct prairie shelterbelt program and provide guidance to administration on assisting landowners in shelterbelt maintenance and planting.

#### Drayton Valley Health Foundation Presentation

Carol Vawk, chair of the Drayton Valley Health Foundation, as well as Dr. Vincent Grant and Ken Brisbin, gave a presentation regarding a plan to convert an existing records space at the Drayton Valley hospital into a simulation lab. The lab would include mannequins and other equipment to allow doctors, nurses, first responders, and others practice first aid and clinical skills.

#### Seniors' Week Proclamation

Reeve Bart Guyon proclaimed June 3-9 as Seniors' Week in Brazeau County.

Seniors' Week has been recognized in Alberta since 1986 to celebrate the contributions of seniors to our families, workplaces, communities, and our province, and to advocate for seniors' rights and voices.

Seniors make a difference in our community in many ways through active community participation that often includes, supporting family and friends, imparting valuable experience, knowledge, and skills to the community as volunteers or as part of the workforce and providing mentorship to younger generations.

The value seniors bring to a community is priceless as they hold our history, have valuable memories and stories of where we come from, and experiences that help us as we look to the future.

#### June 4 2024 Schedule of Fees

Council approved the 2024 Schedule of Fees, with some changes from the previous schedule:

- Brazeau County flags will now be sold at actual cost, approximately \$160
- A fire suppression trailer has been added to the rental fleet

- The damage deposit for no spray signs has been removed
- All cemetery fees associated with grave opening/closing have been eliminated

#### AG-16 Conference Reports Policy

Council approved the AG-16 Conference Reports Policy, which requires Agricultural Service Board members to provide a written report, to be included in the ASB meeting agenda, following attendance at a conference.

The policy was forwarded to Council from the Agricultural Service Board for approval.

#### **RCMP Update**

Staff Sergeant Dwayne Moore of the Breton Detachment and Sergeant Ryan Hoetmer of the Drayton Valley Detachment presented detachment updates.

In Drayton Valley, there has been an 30% increase in total Criminal Code offences for the period of January to March when compared to the same period in 2023, with 121 offences this year compared to 93 in 2023.

In Breton, total Criminal Code offences have risen 6% when comparing the January to March 2024 time period to the same period in 2023, with 161 offences in 2024, compared to 152 last year.

#### Director of Emergency Management

Council welcomed Emergency Management Coordinator Ryan Barbazuk, who will act as the Director of Emergency Management in a emergency situation, and will provide leadership and training for County staff.

#### Warburg Seed Cleaning Plant

Warburg Seed Cleaning Plant manager Tom Luethi and board member Dale Sheetz gave a presentation to Council on the operation of the plant and the importance of local agriculture.

The program provides service to residents of Drayton Valley, Brazeau County west of the North Saskatchewan River (the area east of the river is served by Breton FCSS) and Parkland County.

#### **Eagle Point-Blue Rapids Parks Council**

Eagle Point-Blue Rapids Parks Council executive director Sandra Bannard presented the Parks Council's annual report on its programs, and the effects of the 2023 Buck Creek wildfire.

#### Student **Recreation Package**

# PENALTIES Now in Effect on Unpaid taxes

Brazeau County property taxes were due on June 30, 2024. The combined taxation and assessment notices were mailed to property owners in May. County staff has been busy throughout June answering taxrelated questions and processing payments.

As of July 1, 2024 outstanding taxes are subject to a 1% penalty. Brazeau County Bylaw 889-15 sets out the penalties for unpaid taxes for 2024. Taxes that remain outstanding are subject to an additional 1% penalty on the first day of every month where they remain unpaid. Property owners who have paid a portion of their taxes will be charged the penalty only on the amount left owing.

Penalties are not applicable to property owners who are already signed up to pay their taxes monthly through the Tax Instalment Payment Plan (TIPP).

Those paying taxes after July 1, 2024 are no longer eligible to receive the residential/farmland incentive on the municipal portion of their tax bill.


# Share the road

Commercial vehicles play an important role in moving goods around the province and across its borders. These vehicles are larger and heavier than passenger vehicles, so other drivers and road users should exercise caution and patience when sharing the road with them. Commercial vehicles have large blind spots, take longer to stop than smaller vehicles, and require a wide turning radius. Make sure to give them plenty of room on the road.

#### Facts about commercial vehicles:

• In 2021, truck-tractors made up 2.0 per cent of the total vehicles involved in casualty collisions, but 10.0 per cent of the vehicles in fatal collisions.

- 57.0 per cent of drivers of other vehicles involved in fatal collisions with truck tractors and 38.3 per cent in injury collisions committed a driving error. The most common errors of these drivers were following too closely, violating a stop sign and being left of centre (2017 - 2021).
- The most common driving errors on the part of the truck tractor driver in casualty collisions were running off the road and following too closely (2017 - 2021).
- Truck-tractor drivers are more likely than other drivers in casualty collisions to be fatigued or asleep at the time of the collision (2017 - 2021).
- In 2023, Sheriff Highway Patrol completed 11,953 commercial vehicle and/or driver inspections.

## COMMUNITY EVENT FUNDING

Did you know that there is funding available to community groups to help with costs associated to hosting events in the community? The Community Event Grant is available to non-profit organizations quarterly with application deadlines of January 1, April 1, July 1, and October 1. The goal of the grant is to grow the sense of community while not duplicating efforts.

Past events that have received funding include EPBR's Fire and Ice Festival, the DV100, Drayton Valley 4-H Beef Interclub, etc. Maximum funding available per applicant is \$1,000 as a grant or in-kind resources eg street cleaning. Organizations seeking Community Event Funding must meet the following criteria:

- The organization must provide services in the County's geographic area, including the Town of Drayton Valley and the Village of Breton, to be considered for support.
- 2. The organization must qualify as a nonprofit organization under the regulations of the province.
- 12

- 3. As a general rule, the County does not support grant requests for:
- General operating expenses, debt reduction or general or administrative overhead expenses.
- Events of religion-based organizations (unless the event is secular and does not give priority or preferential treatment to the religious organization or its members).
- Events of educational institutions (unless the event does not give priority or preferential treatment to the educational institutions or its members).
- Political organizations or events; commercial events; advocacy groups; corporations or businesses; and provincially or nationally-based organizations without an organized presence in the County.
- Organizations with an "active" grant may not apply. An "active" grant is a grant that has been awarded but not expended. This grant will not be considered "closed" until a final report has been received on the project or organization for which the grant was provided.





# Brazeau County included in 2024 Federal Livestock Tax Deferral Provision

The Livestock Tax Deferral provision allows farmers that carry on a farming business in a prescribed area who sell all or part of their breeding herd due to drought, excess moisture or flooding to defer a portion of sale proceeds to the following year. When prescribed regions are identified, the list is posted to https:// agriculture.canada.ca/en/agricultural-production/ weather/livestock-tax-deferral-provision

#### How the provision works

- To defer income, the breeding herd must have been reduced by at least 15%.
- Where the breeding herd has been reduced by at least 15%, but less than 30%, 30% of income from net sales can be deferred.
- Where the breeding herd has been reduced by 30% or more, 90% of income from net sales can be deferred.

In a year in which a region has been prescribed, income from the sale of breeding livestock can be deferred to the next tax year when the income inclusion may be at least partially offset by the cost of reacquiring the breeding livestock. In the case of consecutive years of drought or excess moisture and flood conditions, farmers may defer this income to the first year in which the region is no longer prescribed.

# Wetlands are not Wastelands

Wetlands are essentially lands that are wet. They are low lying areas where enough water collects to support water-loving plants, like cattail, rushes, sedges and willow. Wetlands also have perpetually wet soils because they are either saturated with water year-round or covered with water at least some time during the growing season of most years. Sloughs, ponds, potholes, bogs and muskeg areas are all types of wetlands. Wetlands include the area covered by water and the adjacent area of lush water-loving plants called the riparian area.

Wetlands vary in shape, size and permanence. A temporary wetland may have water only after snowmelt or a heavy rain. Whereas a semipermanent wetland will hold water through most years but may dry out after several years of drought. And a permanent wetland will have water present year-round.

Wetlands are not wastelands. They are the connection in the watershed we often cannot see, linking groundwater, surface water in other wetlands, lakes and streams, soil moisture and weather patterns. Wetlands are so closely linked with other parts of the water cycle that drainage can have significant local effects such as lowering



the water table, reducing local precipitation and creating greater temperature extremes.

There are many benefits to leaving wetlands and their surrounding riparian areas intact. Some are subtle, such as increased local soil moisture, reduced flooding, more stable stream flow, improved crop production and better water quality. Other benefits are more obvious such as supplying shelter, forage and water for livestock, habitat for wildlife and fish.

In drought some wetlands completely dry up, sometimes for several years in a row. However, even a dry wetland provides many of the same benefits listed above. Seeding a seasonal wetland while it is dry is a risky venture. There is increased danger of frost in the low area and a very high likelihood of flooding once wetter conditions return. Wetland substrates are usually quite impervious, and may be saline, which results in low crop productivity. Several studies have shown that the costs of draining and cropping wetlands are often higher than the crop returns.

What can you do to manage your wetlands on your farm or ranch? Consider leaving your wetlands intact including the natural extent of the riparian vegetation and an additional buffer of extra vegetation where possible. Not only will this trap more snow in winter, increasing soil moisture and recharging groundwater supplies, but this buffer will also filter out nutrients found in runoff from your pastures or cropped fields, improving water quality in your watershed. Manage grazing in wetlands to prevent overuse and trampling by livestock, and to avoid manure build-up.

- Community and social participation

Deadline for applications is October 31 of the current year. Awards are contingent upon successful completion of Grade 12 and registration in a post-secondary institute.


