The Agricultural Service Board of Brazeau County will provide up to two (2) \$1000.00 bursaries to students residing in the Brazeau County enrolled in a post-secondary institute in pursuit of the following:

- a) Bachelor of Science in Agriculture or Environment from a recognized University
- b) Diploma in Agriculture or Environment from a recognized College
- c) Degree or diploma directly related to Agriculture from recognized community colleges or universities

Bursaries must be used in the year awarded. In the case of the recipients not completing their studies in year of award, all or a portion of the bursary may have to be refunded. The amount will be determined at the discretion of the awarding committee.

Bursaries will be awarded on the basis of the following, in no particular order:

- a) Academic achievement
- b) Agricultural background
- c) Community and social participation

Deadline for applications is October 31 of the current year. Awards are contingent upon successful completion of Grade 12 and registration in a post-secondary institute.
