**ORDER ON VEHICLE WEIGHTS**

**ORDER NO. 25-02**

By order of the Municipal Manager pursuant to Bylaw No. 769-11, being the General Traffic Bylaw of Brazeau County, it is hereby ordered that:

1. **OIL BASED ROADS** in the County will be at 100% gross vehicle axle weights with the exception of:

1. Twp Rd 492 from Range Road 73 east to the Drayton Valley Cemetery at 75%
2. The internal roads of Parview Estates at 75%
3. The internal roads of Country Club Estates at 75%
4. The internal roads of Northside Acres and Fairway Meadows at 75%
5. The internal roads of Rex Block at 75%
6. Lindale hamlet Range Road 53 at 75%
7. The internal roads of River Ridge Estates at 75%
8. The internal roads of Ring Road Estates at 75%
9. The internal roads of Cottonwood Acres at 75%

2. **HAMLETS** in the County will be:

1. Cynthia at 75%
2. Lodgepole at 75%
3. Buck Creek at 75%
4. Rocky Rapids at 75%
5. Violet Grove at 75%

3. **GRAVEL ROADS** in the County will be at 100% gross vehicle axle weights with the exception of:

1. Range Road 35 from Hwy 616 to Twp Rd 474 at 75%
2. Range Road 40 from Hwy 616 to Twp Rd 473A at 75%
3. Range Road 40 from Hwy 616 to Twp Rd 482 at 75%
4. Range Road 44 from Twp Rd 483 to Twp Rd 482A at 75%
5. Range Road 45 from Twp Rd 484 to Twp Rd 483 at 75%
6. Range Road 45 from Hwy 616 south to County boundary at 75%
7. Range Road 45 from County boundary south to Twp 490A at 75%
8. Range Road 50 from Hwy 39 to Twp Rd 484 at 75%
9. Range Road 71 from Twp Rd 495 to Twp Rd 494 at 90%
- A. Twp Rd 474 from Range Road 40 to Range Road 33 at 75%
- B. Twp Rd 481 from Range Road 44A to Range Road 42 at 75%
- C. Twp Rd 482 from Range Road 50 to Range Road 44 at 75%

- D. Twp Rd 483 from Range Road 45 to Range Road 44 at 75 %
- E. Twp Rd 484 from Range Road 50 to Range Road 45 at 75%
- F. Twp Rd 484 from Range Road 85 to Range Road 83 at 75%**
- G. Twp Rd 491 from Range Road 81 to Range Road 80 at 75%
- H. Twp Rd 495 from Range Road 72 to Range Road 71 at 75%

4. **PAVED ROADS** in the County will be at 100% gross vehicle axle weights.


