#### SUSTAINABILITY GRANT INFORMATION

Community Hall Sustainability Funding Policy:

Brazeau County recognizes the strain managing community halls can have on their membership and are making available a funding stream to assist with revenue generation with the goal that the funds would be allocated towards easing the burden of managing and attracting bookings. Therefore, Brazeau County will match revenues generated through hall activity as identified above, excluded all grant funding and donations, up to a maximum of \$18,000. Revenues will be calculated based on the prior year's financial statements as provided.

The following conditions apply:

- (i) the community hall must be structurally sound;
- (ii) adherence to the eight common guidelines within the Community Organization Funding Policy FIN-7;
- (iii) the organization is in active and good standing as per the Societies Act;
- (iv) revenue is generated through regular hall bookings and/or the provision of programs and services to the community; and
- (v) funds cannot be used for capital improvements; those items are to be applied for through the funding stream below if assistance is needed
