Bylaw 1214-25

BEING A BYLAW OF BRAZEAU COUNTY, IN THE PROVINCE OF ALBERTA, TO ESTABLISH THE 2025 SCHEDULE OF FEES BYLAW.

WHEREAS, Brazeau County deems it expedient to set and review, as necessary from time to time, various fees of the Municipality; and

WHEREAS, in accordance with the *Municipal Government Act*, Chapter M-26.1, Revised Statutes of Alberta 2000 and amendments thereto, the Council for a Municipality may set fees for goods or services provided;

NOW THEREFORE, the Council of Brazeau County, in the Province of Alberta, duly assembled enacts as follows:

1. TITLE

This Bylaw may be cited as the "2025 Schedule of Fees Bylaw"

2. FEES

The fees are set out in Schedule 'A', attached to and forming part of this Bylaw

3. REPEAL

Bylaw 1193-24 and any amendments thereto are hereby repealed.

4. EFFECTIVE DATE

This Bylaw shall come into force and have effect upon passing.
